- List of work to be sold.
- Submitted photos (digitally) of work, including front view of booth and artist creating their work.

This is a juried show with cash awards: **First Place** \$500. Second Place \$300, Third Place \$200. Awards are not category specific. No more than 100 artists and artisans will be selected and no more than 12% artisans accepted under the jewelry category.

Booth spaces will be strategically assigned to avoid placing similar works in close proximity. Once a space number is assigned an artist cannot move to another location without permission from the show officials.

Set-up begins at 6am, Saturday, January 24. Space fee will be forfeited if participant fails to arrive and does not contact show officials explaining absence (772) 334-3444.

All artists and artisans must reapply and be accepted by the jury committee. 2025 show artists and artisans will have first-priority to keep their 2025 assigned space if their 2026 application is received by February 27, 2025. (Subject to approval by the jury committee).

Exhibitors bear the responsibility for all set-up and security need for their exhibits. It is our assumption that participants in the show have liability insurance. All fire safety lanes and show rules will be strictly enforced. Overnight security will be onsite from Saturday 7pm until Sunday 7am.

The History

In 1966, local art patron and Jensen Beach Chamber of Commerce board member, Dr. Richard Penick, led the effort to showcase local artists by featuring them in a local art show. With the help of chamber members and local art advocates, they joined together to make it happen. The first Jensen Beach art festival, Festival of the Arts, was held at Langford Park in March.

The name of the art festival became the Sunshine State Art & Craft Show in March 1989. The show invited fine crafters to participate displaying their hand-crafted artwork including glass, photography, mixed media, textiles, jewelry and much more, and was held at the Jensen Beach Causeway Park. A highlight of the Sunshine State Art & Craft Show was the flying of the Mount Rushmore American Flag over the event in 1991.

The Sunshine State Art & Craft Show ended in 1994. For the remainder of that decade, and until the Frank A. Wacha, Sr. Bridge construction on the Jensen Beach Causeway was completed in 2006, the Jensen Beach Art League organized several local art shows. In the early 2000's, a South Florida promotion company brought an art show to downtown Jensen Beach and held the show on Ricou Terrace.

When Ronald Rose returned as President CEO of the Jensen Beach Chamber of Commerce in 2006, one of his first objectives was to return art shows to downtown Jensen Beach. He credits artists from the Sebastian Riverfront Fine Art & Music Festival in helping him launch the downtown Jensen Beach art show rebirth. The current Jensen Beach Art & Craft Show premiered in January 2007 and officially kicks-off the region's art and craft show season.

Please submit three images of your recent work and include, plus one front view of the booth, and one of you creating the artwork.

MULTIPLE ENTRIES

Artists must choose <u>one-category</u>. Items for sale must reflect the category on application.

ARTIST MUST BE PRESENT

Original works of art must be attributed solely to the displaying artist present at the booth during the show.

JURY COMMITTEE & JUDGES

Decisions by the Jury committee and Judges are final.

ARTWORK THAT IS NOT ELIGIBLE

Artwork from molds, kits, including other commercial methods, or resale items, are not eligible to be displayed.

NO REFUNDS will be made after 12/31/25 for any reason.



You are invited to participate in the **20th Annual Jensen Beach Art & Craft Show**. The show kicks-off the local art show season and is considered one of the area's most authentic art and craft shows. We welcome local, regional, and national artists and artisans to apply. New artists, and artists that are participating in an art show for the first-time are also encouraged apply.

All works must be original and attributed solely to the on site artist. Artwork from molds, kits, including other commercial methods, or resale items are not eligible to be displayed.

For uniformity all tents must be white and include weights. Booth signage is required and must be professional. The name of the artist must be clearly displayed.

Set-up will begin Saturday, January 24, 2026 at 6am. All works must be for sale. Booth space measurement must be 10' x 10'. All work must be contained in the assigned space unless previous arrangements are made with show officials. Each artist must provide an appropriate and secured display for outdoor exhibition. No vehicles or trailers are allowed near booth spaces or in show area during show hours.

No loud generators are allowed. No amplified music is permitted. Nails or screws placed in the streets or parking lots are strictly prohibited. Tent weights are mandatory.

Each artist is responsible for collecting 7% Florida Sales Tax and remit tax to the Florida Department of Revenue.

An application is a commitment to attend the show and remain for the entire event. Exhibitors breaking down prior to Sunday at 4:30pm, will forfeit an invitation to participate in future shows unless excused by a show official.

Displays will be viewed by show officials, who have sole discretion to require the removal of any work which violates show guidelines, including inappropriate behavior.

If your assigned space is on the Boulevard, please read.

All exhibitors assigned a space on Jensen Beach Boulevard agree to have their exhibit space dismantled and removed no later than 7pm in order to reopen the street to traffic. Failure to meet this requirement will result in forfeiture of Boulevard space at future shows.
